Pension Report

Quick Review of 2007

The Funds' investment portfolio was heading toward a 12% return for the year until the first week of August. That's when the "credit crunch" and sub-prime mortgage crisis caused major volatility, especially in U.S Equities, which is the largest asset allocation. At the end of the 3rd quarter, the actual asset allocation was as follows: 45% in U.S. Equities, 29.4% in Bonds, 19.1% in Foreign Equities, 5% in Private Equity, and 1.5% in Real Estate.

Preliminary review suggests the Fund's portfolio return will be about 9% for 2007. The fund's investments in Private Equity and International Equity were the best performers. The investment committee is moving forward, changing our asset allocation to increase alternative investments in Real

Estate, Infrastructure, Foreign Equities and Private Equity (Allocations to U.S Equities and Bonds will be reduced).

In 2007, there was a slight increase in Retirees in 2007, 336 compared to 328 in 2006. The actual figures are listed here.

Not much going on in our State Capital, except for a lot of infighting. Hopefully, they will get their act together and get some work done.

We have several elections coming up this year. One is for the office of the Cook County States Attorney. While it's important for people to support their respective political parties, it's also very important to elect the most qualified person for the position. Please keep that in mind when you vote.

Speaking of elections, there is an FOP election in March, and nominations for officers to the Retired Chicago Police Association are due at the February 10th meeting. I just recently turned 65, and found out that I had to put my wife on my supplemental BC-BS hospitalization insurance. If I didn't, at a later date, she would have to go through a lengthy process (six months) to get certified, and there is a good chance they could reject you. It's a big chance to take. At the

present time she is getting free hospitalization through her current employer. This is not the fault of the Pension Board, but it is the policy set forth by the City of Chicago. I am making our current contract negotiating team aware of this, and asking them if they could get the City to waive the enrollment time for a spouse to no later than age 65 or at their request. This would apply only to Sergeants who are retiring or retired.

Please take notice of the Corned Beef and Cabbage dinner information in this issue. Hope the weather will be better on the south side this year.

Finally, I and a bunch of other police and retirees have to say that Carol at the Pension Board is doing a great job assisting us with information on medical benefits. Mr. John Gallagher you have an awesome worker there. ⚡
