With that in mind I want to remind everyone that all Sergeants now have six (6) Personal Days that can be used. Personal days are worth a tour of duty if used. # Vice President Report

## Membership Benefit

One of the benefits that the association provides to its members is a suspension reimbursement. Each and every full member of the association is eligible to take advantage of this benefit once per calendar year, provided that the member files a grievance in a timely manner. Upon approval of the Board of Directors, members will receive \$75 per day for up to five (5) days of suspension for which a financial loss was realized. The Board of Directors is currently considering an increase to this amount. If a member was granted options to suspension and opted to forfeit compensatory time, personal days, or baby furlough days, he/she is still eligible to take advantage of this benefit. This is due to recent gains in the collective bargaining agreements that allow for the sell back of those hours or days. In order to be considered for this benefit, the member must...

...be a full member at the time of the incident that gave rise to the suspension.

...be a full member at the time that the suspension is served.

...complete a Suspension Reimbursement Form (available on-line on CPSA web site).

...provide a copy of the department suspension notice.

...agree to refund the reimbursement upon a positive outcome through grievance procedure.\*

\*Due to the recent successes through arbitration and summary opinion resulting in members having suspensions reversed.

The benefit is not available for suspensions stemming from a violation of residency rules, vehicle licensing rules, failure of drug and alcohol testing, indebtedness, or criminal charges. # 2010 CPSA/PBPA Unit 156A's 48th Annual Golf Outing

Silver Lake Country Club has treated our organization very well, and we have had many compliments. # Treasurer's Report

Since taking over the finances of the Association since November, the Board of Directors has taken steps to ensure your Association's money is safe and secure. As posted on the Members section of the Sgt's website, some major points are re-covered here.

1. All checks issued by the Association require 2 signatures.
2. Collection of membership dues has been made a direct deposit into the Association account.
3. A computerized accounting program has been installed to track income and expenses.
4. As part of the Treasurer's Report, a transaction register is presented to the Board of Directors monthly, detailing where all monies were spent.
5. Members are eligible to view the books with scheduled appointment. (I'm not in the Assoc. office daily)
6. A daily printout is filed showing bank account balances.
7. The format for submitting reimbursement requests has been standardized.
8. An outside audit is being conducted, by the accounting firm approved by the Board.
9. Bills are being paid on time.
10. An annual budget is being created.

To keep closer tabs on your money, the Board of Directors has established a Finance Committee made up of the Treasurer and Financial Secretary.

As part of their duties, the Finance Committee of the Board of Directors will be meeting to discuss the following items:

1. All checks issued by the Association require 2 signatures.
1. Is the Association getting the best return on it's assets under our current set up with CHASE?
2. Making certain we continue to pursue forfeiture proceedings against the former president, in an attempt to recover misappropriated assets belonging to the association.
3. Work with the accounting firm to determine amount of estimated loss.
4. Make a proposed budget to maintain and control Association spending.
5. Continual review of checks and deposits to Association accounts.

# Pension Report

## Thanks and farewell to Mr. Reuche

This May Pension Board meeting was the final one for the longest serving board member, Robert Reuche. Mr. Reuche was appointed to the board in 1991 and was the Board President for the last several years. He retired from Northern Trust in 1990 after a very long (40 years) and successful career. He radiated polish and optimism; he will be missed.

Mr. Michael Conway was appointed to the Board by Mayor Daley to replace Mr. Reuche and he attended his first Board meetings in June. Mr. Conway has worked for more than 24 years with Combined Insurance (now part of Aon).

In the June meeting, the Board elected Ken Hauser (previously the Vice-President) to be the new Board President. Lt. James Maloney was elected as the new Vice-President.

## Changes in Investment Consultant

Every large pension fund uses investment consultants that help the fund develop an overall investment policy and monitors its operation. The fund's primary consultant since 1983 has been Ennis-Knupp (EK). Ennis-Knupp's consulting for the fund was terminated at the June Board Meeting by a 4-3 vote. I voted to retain EK. I want to thank all of the people at EK for the good work they have done. I especially want to thank P.J. Kelly, who was the lead consultant for the fund. P.J. is a hard worker who cared deeply about the police pension and all of its participants. The fund's real estate advisor, Courtland Advisers, was also terminated at the June meeting. New England Pension consultants were hired to replace both EK and Courtland.

## Pension Legislation

The Illinois Legislature has adjourned until the veto session in the fall. The Illinois Legislature website states the veto session will begin on the 16th of November.

S.B. 3022 was passed. This bill allows prior service credit for military service prior to CPD appointment. Veterans may now buy up to two years of service. Purchasing this service credit is similar to portability in that it is very expensive.

H.B 5366 did not pass. This was legislation that would have removed the representative form supervisors to the Pension Board and replaced them with Patrolman.

H.B. 5873, a downstate pension bill was also stopped. This would have created a two-tiered pension system. The PBPA, FOP, and Fire Local 2 worked hard to stop the bill and should be congratulated.

Back in April of this year I had the opportunity to talk to Attorney Clinton Krislov who was the lead attorney in the Korshak case. Mr. Krislov was a speaker at the meeting of the Retired Chicago Police Association's May meeting. In summary he related that the Korshak decision represented those who retired in and before 1989. Those who retired after 1989 were more or less grandfathered into the decision. By order of the court this decision must be revisited by the court in June of 2013, and Mr. Krislov is the attorney that is recognized by the court as representing the retirees.

It has been frequently stated by some individuals that there is nothing to worry about because the City will not take away our health benefits. To a certain degree that may be true, however what will you have to pay for those benefits. Do you trust the City??

It was Mr. Krislov's thought that there should be a more recent group of retirees and actives who should be represented before the court. Whatever happens in June of 2013 will affect not only retiree, but active duty officers who anticipate retiring in the future. Also, there will be a new judge assigned to the case as the current judge is being promoted, and at this time there is no indication who the judge might be.

I am planning to have a meeting in the near future to discuss the 2013 issue as well as benefits that are not currently available to retirees and their spouses. Remember 2013 is just around the corner. ⤴

# Police Chaplains Ministry

June, 2010

Dear Friend,

I'm uncomfortable writing this letter, and it's the first time in 40 years I've had to do this, so let me come right to the point. The Police Chaplains Ministry (a 501c3 not-for-profit) has provided chaplain services to the C.P.D. thanks to **the strong support of Chicago police officers** and a very few civilian donors. One of those very generous civilian donors had a recent change in the religious make up of their board of directors, and our Ministry lost more than half of our funding. That's life. Some charities send out weekly or monthly requests, but because of that one exceptional donor I only had to come to you 2 or 3 times annually for support. That's changed.

A businessman looked at our numbers recently and commented, "**You're a very lean operation.**" True. There's no fat here (except me): No cell phones, travel, entertainment, meals, gifts, etc. Because we're low key, **some folks confuse us with other organizations, but your Police Chaplains Ministry is independent (which is why we've lasted so long).** Every cent of what you give stays in the police chaplaincy and our most recent audit shows over 92 cents of every dollar goes directly to our work. **We neither get nor give any funding** to the Archdiocese of Chicago, Mercy Home (they've given me free office space for decades, though), Chicago Police Memorial Foundation (superb!), St. Jude League (no connection at all), or the Gold Star Families (we've proudly hosted first class events for over 25 years).

When I was in the seminary in the 1960's we were taught to never "trumpet your good works." So the work of police chaplains here remains mostly invisible, except for the individual officers we care for. We understand life in the police world far better than the local clergy do. We know the work of the street copper has moments that make God proud of the human race. And we know how messy police work is. You need chaplains when life gets tough, so (here comes the trumpet) we spend a lot of time at wakes, funerals, emergency rooms and on the phone with those in a stormy time. We stay in touch with those few imprisoned (who'd probably not be there if they hadn't decided to become the police), those who are in the last weeks of life, those who are trying to ride out a serious illness or divorce, those who've lost loved ones, and those who find life confusing and painful. We are often the first phone call for help from an officer in pain.

We make regular referrals to counseling pro's. **We've given over \$300,000 during the holidays to needy Chicago police families here, spent over \$300,000 helping pay officers' bills** for addiction treatment, sent over 300 excellent 'care packages' to our CPD officers in the military (Desert Storm and Iraqi Freedom), opened and furnished St. Michael's House (now CPD's EAP) and put on seminars on stress, losing a child, surviving divorce, effective parenting, etc.

We provide thousands of respectful memorial cards (most recently for P.O. Thomas Wortham IV, R.I.P.) at the funerals of all C.P.D. line-of-duty deaths (instead of the generic funeral home cards). We ride the streets with you, respond 24/7 to critical incidents, celebrate Sunday Mass 'for police only,' and write for the F.O.P. newsletter (trying to tickle the police soul and remind you of who you really work for). From PPO's to those with 'C.P.D. retired' after their name, we're available. We even send CPD sympathy cards across the nation to every department that has a line-of-duty death and get some moving thank-you's in return. **Could the officers of the C.P.D. survive without their police chaplains? Of course.** But I like to think that the C.P.D. officers are the stew and the chaplains are the salt and pepper...coppers are the coffee, chaplains are the cream and sugar. **We make it better . . . I hope.**

Sometimes people think I sit around and wait for the next notification from Operations Command: "Father, we've got a police officer shot..." Yep, that's the ultimate critical call for any police chaplain and it's always upsetting and infuriating. But in between those rare moments, I laugh at life with you. I hug and get hugged. I hold hands. I give bad news. I listen. I weep. I get angry and disgusted. I wait. I drive with you from the hospital to the M.E.'s back door. I give good news. I defend you. I tell of your heroism and competence. I am with you. No one expects a 66 year old priest to sometimes be there on hot calls but that's still where all the fun is for The Real Police, so I go if I'm close, and it's still fun for me, too! And I've never stopped being proud when I see you in action. Only you and God know how good you really are, and that's sufficient. If the citizens, the polls and the media never get it, too bad for them. My two partners know you and believe in you: Fr. Dan Brandt, presently the pastor of a south side parish, has been working with me to learn the police world. I invited him aboard; Cardinal George went along with my choice. My partner, Rabbi Wolf, says we are the luckiest guys in the world, because we get to spend our days and nights with you. The three shepherds agree: We've got the best flock anywhere.

Our next event will be at the end of July . . . we'll take about 80 members of the Gold Star Families on a lunch cruise on the Odyssey liner on Lake Michigan, all expenses paid by the Police Chaplains Ministry as we've done for the last 15 years. I hope you'll help us.

We've gotten this far with your strong, generous donations 2 or 3 times a year. Now I'm uncomfortable because I will have to come to you more often due to the loss of that one big donor. Police work is a matter of the heart and soul, and so is your police chaplaincy.
